- Quality Auditors are duly trained and evaluated by the association, with the goal of delivering consistent audits. This is achieved by ensuring their competences are appropriate with regards to their responsibilities, their GxP expertise and their independence.
- The selection and the accreditation of the EXCiPACT<sup>™</sup> Registered Certification Bodies is made according to the ISO-17021 Quality Standard and its Appendix defined in the EXCiPACT<sup>™</sup> Quality Standard. The Quality Standard developed by the EXCiPACT<sup>™</sup> association is periodically updated considering the changes of Quality Requirements.
